#### CONVOCATION UPDATE

All priests, both diocesan and religious, are encouraged and expected to attend the Ministry to Priests Days May 10-13 at Moody Gardens Hotel and Convention Center in Galveston. #### CHANCERY CLOSED

#### UPCOMING SECOND COLLECTIONS

The St. Mary's Seminary Collection (Corpus Christi Sunday) is the weekend of **June 5-6, 2010**. Remember the **entire** offertory collection (100%) for that weekend is to be sent to the chancery for the seminary.

## FIRST COMMUNION CERTIFICATES NOT REQUIRED FOR CONFIRMATION

Since First Eucharist is not a required registered sacrament, many parishes do not maintain a completely accurate First Communion register. A letter from a parent stating the child has received the Eucharist is certainly sufficient though it is not a necessary document in order to properly prepare for confirmation. A valid baptismal certificate is the only document canonically needed.

#### FEAST OF THE ASCENSION

Reminder: The Texas Bishops voted to move the Feast of the Ascension to the Seventh Sunday of Easter beginning with the Easter Season of the year 2000. The Feast of the Ascension will be celebrated on the Sunday immediately following Ascension Thursday.

### SUMMER REPLACEMENT PRIEST - PLAN EARLY

If you plan a vacation from June to late August, please begin now to look for priests to cover your Masses.

Though priests are responsible for finding their own replacements, if the visiting priest is without faculties in this Archdiocese, he must be approved for ministry from the Chancellor. The visiting priest must provide a recent letter from his bishop or religious superior stating that he is a priest in good standing and has permission to be in the Archdiocese.

#### GODPARENTS AND TESTIMONIAL LETTERS

To be a sponsor for either Baptism or Confirmation, it is required that the person be a baptized, confirmed and practicing Catholic (c. 872-874). If the sponsor is married, the marriage must be a valid and recognized marriage in the Church. No letter of suitability from the sponsor's parish is required by canon law or diocesan guidelines. If there is concern, the parish *may ask the sponsor* to sign a letter stating that they meet the requirements and conditions to be a sponsor, but this is not a requirement.

Please inform DRE's, baptismal teams and others that there is no requirement for such letters of testimony from the priest or parish of the Baptism or Confirmation sponsor.

#### MARRIAGES OUTSIDE THE DIOCESE

When parishes are preparing couples for a marriage that will take place outside the Archdiocese of Galveston-Houston, please be sure to send the completed marriage packet (include current baptismal certificates for bride and groom and Affidavits of Freedom to Marry, 2 for each the bride and the groom) to the chancellor's office approximately one-month before the scheduled wedding date. necessary so that the Archdiocese can issue a nihil obstat on the preparation materials and provide a letter granting permission for the couple to be married outside the archdiocese. As a part of the marriage preparation materials, the pastor should include a letter granting permission for the couple to marry outside his parish. Some (Arch)dioceses will not allow the wedding to take place if these permission letters are not included in the marriage packet.

#### MASS STIPENDS

The Chancery receives numerous requests for Mass intentions. If any parish has more Mass intentions than can be said in a reasonable period of time, please forward them to the chancery. These stipends help priests in parishes with few stipends and priests in the Missions.

## TEENAGE EXTRAORDINARY MINISTERS OF HOLY COMMUNION

All parishes and high schools are reminded of the archdiocesan policy regarding the minimum age for Extraordinary Ministers of Holy Communion. To be eligible for this ministry the person must demonstrate a personal and spiritual maturity, be properly prepared, be fully initiated in the Catholic Church and be 18 years of age or a senior in high school.

To: All Pastors

My brother priests:

I ask you to please remind your parishioners of the collection on the Solemnity of Corpus Christi (weekend of June 5-6, 2010) for the support of men studying for the priesthood for our Archdiocese and the religious communities which staff some of our parishes. Your personal appeal for a very generous contribution from each parishioner will help to realize an increase over the \$1.704,479.38 reported last year.

Half of the collection from parishes staffed by religious priests will be returned to their communities. In 2010, \$170,633.49 of the 2009 collection was forwarded to the religious orders for the support of their seminarians.

Archdiocesan seminarians study not only at St. Mary Seminary in Houston, but also in Dallas, San Antonio and Hales Corners, Wisconsin. The total budget for the fiscal year 2010-11 is \$4,068,953.00. This includes the costs associated with the operating of St. Mary Seminary as well as the expenses of the education of seminarians, the continuing education of priests and the training of permanent deacons and laity. Of this amount, the archdiocesan subsidy is \$2,364,473.62.

The Trust Fund is able to cover about half the expense, but the collection is truly required to make up the balance of funds needed. A generous response from each parish is deeply appreciated and needed. Please remember that the total offertory collection for the weekend of June 5-6 is to be forwarded to the Chancery by July 31st.

I ask you to print the announcement below in your parish bulletin for the weekend prior to the collection.



The Council met in the Board Room of the Nold Education Building at St. Mary's Seminary. Cardinal Daniel DiNardo presided. Fr. Sean Horrigan called the meeting to order at 10 a.m. Msgr. Chester Borski offered the Opening Prayer. Fr. Sean Horrigan took the roll.

MINUTES: The minutes of Dec 1, 2009 were accepted as presented. Msgr. Borksi moved the acceptance of the minutes and Fr. Huber, C.S.B. seconded it. They were accepted by a voice vote. Fr. Horrigan welcomed Frs. Cahill, Felix and Pitre as the new members of the Council.

<u>ELECTION OF CHAIR AND SECRETARY</u>: As secretary, Fr. Horrigan explained the bylaws for the election of a new chairman. Fr. Gietl nominated Fr. Horrigan, and no other nominations were offered. Fr. Horrigan was elected by a voice vote. He then explained the bylaws for the election of a secretary. Frs. Felix and Huber were both nominated, and after a paper vote, Fr. Huber was elected the new secretary.

<u>CARDINAL'S COMMENTS</u>: Cardinal DiNardo thanked the newly elected. He then acknowledged and thanked Bishop Vasquez for his service to the Archdiocese and on the Council as this was his last meeting prior to his installation as Bishop of Austin. Bishop Vasquez thanked Cardinal DiNardo and promised to pray for the Presbyteral Council.

ST. MARY SEMINARY STRATEGIC PLANNING: Fr. Cahill distributed a booklet entitled "Imagine 2016: The Strategic Plan for St. Mary's Seminary" along with a four-page handout which reported the "All Student Stats" detailing the demographic information of the students (seminarians, lay students and those in the diaconate program) who study at the seminary, as well as a printed power point summary of the plan.

The process of St. Mary's Strategic Plan was explained. The Seminary Board has approved of 22 strategic goals which have been prioritized, and five committees have been established. Facilities currently house 45-58 resident seminarians; the plan envisions 200 seminarians in residence. The current facilities were built to house 150 seminarians in 1954. They can handle 108 seminarians today, thus there is a need to expand. In Texas, 14 of the 15 dioceses participate in distance-learning classes hosted at St. Mary's using modern interactive technology now present in four classrooms. There is a need for more offices for faculty. An architect will soon be chosen to begin work on a formal Master Plan.

After having reviewed feedback from former seminarians as well as the report of the apostolic visit, an action plan was developed for Priestly Formation. The primary mission of the seminary has and always will be the training of priests. It is clear that more priests are needed to staff the seminary as formation directors, spiritual directors and faculty. There is a need to develop and implement a plan for training future formators. Accreditation work towards the STL degree has begun, and the development of a Spiritual Institute was discussed. It is recognized that there is a need to develop a plan to both recruit and retain seminarians. Fr. Cahill pointed out that the savings of the Seminary finances has grown and reviewed the anticipated revenue for 2011.

Msgr. Borski asked for clarification over the current program; Fr. Cahill explained that it is still a practice, first implemented in the mid-1980s, to send undergraduates (philosophy) students to Holy Trinity Seminary in Dallas and graduate students (theology) to St. Mary's in Houston, with an exception that men over the age of 35 may complete pre-theology in Houston.

Msgr. Rossi commented that the new plan is very optimistic and must assume a large price tag as well as an increased budget. Fr. Cahill explained that once the Master Plan is in the process financial details will have to be worked out with the possibility of a Capital Campaign to build the endowment and fund the expansion.

Mgsr. Borski pointed out that now is an opportune time since there are several bishops (Austin Corpus Christi and Brownsville) who have a connection to St. Mary's Seminary.

Cardinal DiNardo recognized the need to develop such an envisioning plan considering the age of the current buildings. He cautioned that such an ambitious plan could be very expensive. There is no intention to sell any of the land currently owned by the seminary. The major focus of the seminary must be for the formation of men to be ordained priests: the Apostolic Visitation was clear on this point. While other good things, such as the diaconate formation for various dioceses using interactive technology, are happening on

campus their good work is not equal in nature to the seminary's major focus of priestly formation.

<u>UPDATE ON CENTER FOR FAITH AND CULTURE</u>: Fr. Donald Nesti, CSSp with Dr. Adam Martinez presented the new degree program developed at the University of St. Thomas within the Center for Faith and Culture. The Center has recently relocated to the UST main campus from the seminary. The new program is designed to assist the Church in its role of evangelization in the current American culture. It is a response to the call to Faithful citizenship by the USCCB and is intended to serve those who work for the Church. It will address the points of secularism and relativism predominant in our American culture, calling for Catholics to bring a Catholic voice to civic matters.

Beginning in the Fall 2010, a 36-credit Masters program will be offered with an 18-credit core. A brochure describing the program was distributed along with a two-page explanation of the degree plan.

Cardinal DiNardo inquired as to the core faculty of the program. Many of the professors are currently on the faculty of Theology at the University of St. Thomas, and there will be some adjunct faculty. The Cardinal also inquired as to the extent to which the American Southwestern culture, highly influenced by Hispanic Catholics, would be addressed in the core. Fr. Nesti responded that while the issue of the dominant culture affecting immigrant groups is part of the core, that Hispanic influence on our culture needs to be considered further.

Several priests asked further clarifying questions, with Fr. Nesti and Dr. Martinez provided the following clarifying information:

- The program does include a certain amount of ecumenism and inter-religious dialogue, without compromising the Catholic focus.
- Location: classes will take place both on the main campus of the University of St. Thomas and at St. Mary's Seminary.
- Some may opt to participate in the certificate program of 18 credits rather than do the entire Masters.
- This year the tuition is \$330 per credit hour; there is a lower rate for auditing a class.

Msgr. Rossi suggested establishing a relationship with the Greater Houston Partnership, in which many good and influential Catholics are involved.

BUDGET CONSIDERATIONS, CENTRALIZED PAYROLL AND PRIESTS' RETIREMENT ISSUES: Mr. David Hessel, CFO of archdiocese, addressed the Council together with Ms. Diane Blankenship, Director of Human Resources and Benefits, Ms. Heidi Henrichs, Comptroller, and Ms. Christina Deajon, Vice Chancellor.

The Fiscal Year 2009-10 report was reviewed. Audited statements have been posted on the Archdiocesan website, with a summary having been printed in the Texas Catholic Herald. Two costly events have negatively impacted the 2009 fiscal budget: Hurricane

Ike and the unstable financial markets effect on the portfolio, creating an underfunded pension plan. \$2 million in recovery funds are being put into safer investments. There will be no increase in business insurance rates this year after last year's increases. There will be a mechanism to give parishes some credits back once the parish has implemented risk avoidance steps and a Disaster Recovery Plan.

The Archdiocese is attempting to break even with health insurance expenses. A second handout was distributed: The 2011 Budget Process Program/Ministry Survey. Because of the current fiscal situation great prudence must be exercised with the upcoming year's budget. While there continues to be a hiring freeze, the survey is intended to review the activity of each ministry of the Chancery with an emphasis on finances in order to ensure fiscal responsibility. The number of employees in each ministry will be reviewed. While there is no intention of reducing the number of employees by any particular percentage, personnel changes may be made and some may be reassigned to areas where there is a greater need. Not every retiring person may be replaced. Each department is met on a quarterly basis to review spending and its alignment in the set budget for the year.

The Chancery recognizes four "business lines" or "buckets" in which the budget falls: Business insurance, Health insurance, DS&L bank, and Programs. A "zero dollar" investment return is budgeted so that if there is any investment return it will help the budget. Fr. Pitre asked why there is such an operating loss in DS&L; Mr. Hessel pointed out that the figures exclude investment returns. In response to a question raised by Msgr. Rossi, Mr. Hessel pointed out that he was working on a draft of projected budgeting and salaries for Archdiocesan employees that may be helpful as individual parishes set their salaries for the coming year.

A third handout was distributed which considers the possibility of using a centralized or standardize payroll in the archdiocese for FLSA issues, group benefits, pension processing, bookkeeper issues, tax implications, and collection issues. A list of archdioceses was presented with the extent to which each one uses such a system.

Msgr. Rossi stated that the archdiocese looked into this issue 10 years ago, and at that time decided against centralized/standardized payroll. Concerns included the fact that canonical parishes must be autonomous: parish employees are not archdiocesan employees and parish property is not the bishop's property. Pastors must retain their canonical rights as far as hiring and firing employees, but the archdiocese created boundaries/set standards for parish hiring.

Ms. Blankenship pointed out that the archdiocese does not do parish hiring, but that perhaps a system of using an outside payroll firm such as ADP would help parishes retain their autonomy yet give the Chancery access to the payroll activity of the parishes. Msgr. Rossi suggested that the focus needed to be on helping those parishes which are in most need of help because they struggle with payroll and employee issues.

Fr. Patout asked if pastors are given reports when problems or discrepancies are discovered by the Chancery. Ms. Blankenship responded affirmatively. Fr. Pitre pointed

out that most parish bookkeepers are doing a fine job. Ms. Blankenship made reference to the fact that many come to the archdiocese for training and are hungry to learn. Fr. Felix asked whether or not trainers go out to parishes to help, and an affirmative response was given. Cardinal DiNardo stated that indeed there are some parishes that really need help and guidance with their bookkeeping, while the majority of parishes do not have such a need.

A fourth handout entitled "Diocesan Priest Retirement" was distributed. The report presented a summary of the compensation and benefits of retired priests, comparing national averages of pension, vesting, portability, social security allowances, housing, benefits, continuing education, savings plans, auto allowances, retirement age and other information to those of the Archdiocese of Galveston-Houston. It was pointed out that the current archdiocesan plan is not breaking even and needs a funding source. Fr. Horrigan asked if a subcommittee was needed to deal with these issues. Ms. Blankenship responded positively to the idea, and also stated that the Chancery was willing and happy to receive other ideas. She likewise responded positively to Msgr. Rossi's suggestion that the Priests' Retirement Manual be revised. Msgr. Rossi also pointed out that there is a great need to educate younger priests about investments and retirement planning since they cannot rely solely on their pensions.

ANNOUNCEMENTS AND CONSULTATIONS: Cardinal DiNardo announced a Mass in celebration of gratitude for the years of service of Bishop Vasquez. A vespers and dinner for priests will also be held. Bishop Vasquez will be installed as Bishop of Austin on Monday, March 8, and priests are highly encouraged to attend.

The announcement of a new Chancellor to replace Bishop Vasquez is imminent, and the announcement will first be made to the priests of the archdiocese.

The Cardinal has requested from the Apostolic Nuncio and Rome that two auxiliary bishops be granted to the Archdiocese. This process will take several months and patience is needed.

Catholic parishes collected in excess of \$1 million for Haiti relief efforts in the Archdiocese.

The new San Jose Clinic is about to be dedicated. It is now open to the public and serves many uninsured people, both immigrants and natives alike. It is the oldest free Catholic clinic in the United States.

The Priests' Lenten Day of Prayer will be held on March 18. Cardinal DiNardo, Archbishop Fiorenza and Bishop Rizzotto will offer reflections on priesthood.

Bishop-elect Michael Mulvey will be installed as the Bishop of Corpus Christi on March 25. He is a former faculty member of St. Mary's Seminary and a priest of the Diocese of Austin.
