HOLY DAYS OF OBLIGATION

On back to back occurrence of Sunday and Holy Days, there is a precept of Eucharist participation for each day. However, whenever January 1, the Solemnity of Mary, Mother of God, or August 15, the Solemnity of the Assumption, or November 1, the Solemnity of All Saints, falls on a Saturday or on a Monday, the precept to attend Mass is abrogated (NCCB, 11/17/92, Congregation for Bishops, 7/4/92). While the Holy day obligation is automatically abrogated on these days, the liturgy of the feast is still to be celebrated in every parish and institution at a convenient time in such a way that the dignity of the feast is maintained.

MARRIAGES OUTSIDE THE ARCHDIOCESE

When parishes are preparing couples for a marriage that will take place outside the Archdiocese of Galveston-Houston, please be sure to send the completed marriage packet to the chancellor's office approximately one month before the scheduled wedding date. necessary so that the Archdiocese can issue a nihil obstat on the preparation materials and provide a letter granting permission for the couple to be married outside the archdiocese. As a part of the marriage preparation materials, the pastor should include a letter granting permission for the couple to marry outside his parish. Some (Arch)dioceses will not allow the wedding to take place if these permission letters are not included in the marriage packet.

To avoid delay, carefully review marriage packets to ensure that all documents are properly executed, signed and that current baptismal certificates and affidavits of free status (2 each for the bride and groom) are included. Also include the name and address of the parish and (arch)diocese where the wedding will take place.



Minutes Meeting of June 1, 2010

The Council met in the Board Room of the Nold Education Building at St. Mary's Seminary. Cardinal Daniel DiNardo presided. Fr. Sean Horrigan called the meeting to order at 10 a.m. Fr. Brendan Cahill offered the Opening Prayer. Fr. Paul Felix took the roll.

MINUTES: The minutes of February 16, 2010 were accepted as presented. Fr. Zanatta moved the acceptance of the minutes and Fr. Barrosa seconded it. They were accepted by a voice vote. Fr. Horrigan welcomed Fr. Christian Riesbeck, C.C in attendance as an observer. Fr. Horrigan commended Fr. Clint Ressler for hosting a Memorial Day gathering for priests at St. Rose of Lima parish in Houston. It was well attended by more than 20 priests.

REVIEW OF ARCHDIOCESAN BUDGET: Mr. David Hessel, Chief Financial Officer for the Archdiocese, accompanied by Ms. Heidi Henrichs, Controller, presented a summarized budget for the fiscal year July 1, 2010-June 30, 2011. He covered the following:

Budget ledger showing the Archdiocese operating at a loss of approximately \$370,000 and a total loss for approximately \$2.5 million, due to the granting of the Co-Cathedral organ to Sacred Heart parish.

Assumptions for Fiscal Year 2011:

1. Business insurance – FY11 rates will remain flat across all lines. Property values will also remain flat. Worker's comp rates are based on actual FY10 payroll

- dollars, and liability rates are based on census data provided during annual parish survey.
- 2. Health insurance Due to the change to Aetna plan on January 1, 2010, we have budgeted the health insurance plan at a slight loss. We are hopeful the plan will actually break-even, but there is too little historical information available as there is only four months of experience data.
- 3. DS&L investments We have budgeted no investment returns; therefore the DS&L fund is budgeted at a loss. If market performance remains consistent, the DS&L will operate in the black during FY10-11. Accounting office believes it is conservative to budget for no return.
- 4. DSF grants All DSF grants (e.g. Catholic Charities, high schools and St. Dominic Village) have remained flat with no increase of decrease. These grant amounts have remained consistently flat since at least FY08. Total FY10-11 DSF grants are approximately \$1.5 million.
- 5. Inner City Teacher Benefit Grants These grants are also remaining flat in FY10-11 as compared to FY09-10. However, the benefits will be allocated among 13 schools vs 12 schools as Holy Ghost has been added to the list of ICCS schools.
- 6. Allowance for bad debt Approximately 1% of revenue (diocesan assessments, business insurance and health insurance) has been budgeted as uncollectible and will be funded from Aid to Poor Parish Fund.

Finance Council reviewed the budget and recommended approval subject to leadership and management team review and some cost saving options:

- 1. Reduce operational footprint in Galveston.
- 2. Reduce our real estate portfolio.
- 3. Look at the retirement program.
- 4. Conduct a multi-month study of our programs to determine whether they are still relevant.
- 5. Consider unpaid furloughs.
- 6. Look at restructuring of departments.

Ms. Henrichs led the Council through looking at the proposed budget in greater detail showing how Diocesan Services Fund (DSF) and Cathedraticum funds are broken out in the Budget. The budget reports on its funds of grants that are provided on either a recurring and non-recurring basis.

Fr. Cahill asked for some concrete examples of what some of the grants look like. Mr. Hessel gave the example of a parish that may not be able to afford part or all of flood prevention measures necessary for preventing greater losses.

Ms. Henrichs noted that the Finance Council wanted to focus on the pension program. They are in the process of gathering facts for informing sound decisions. Ms. Henrichs has been working on recreating (reorganizing) the accounting for pensions so as to ascertain clearer information concerning the number of people employed, the correct calculations of the amounts owed, and are the parishes/schools paying the correct

amounts owed. This will aid tracking and verifying accounting so as to flag and remedy problems.

Msgr. Rossi thanked Ms. Henrichs for all she is doing to improve our accounting procedures and structure. He asked that we look at the way we market the 10 percent aid to poor parishes fund.

Fr. Horrigan inquired how the archdiocese is aiding struggling parishes to improve their accounting and finance management. Mr. Hessel indicated a success in one instance where volunteers helped a parish that was having trouble to turn around financially. Msgr. Scheel asked if the aid to poor parish fund was used to pay bad debt, but Ms. Henrichs said that it is used only to help parishes with expenses that they cannot afford.

There was some discussion around parish twinning. Mr. Hessel spoke about other models that are being considered that have come out of the Meitler study of parochial schools. The discussion turned to the issue of support of schools in parish-to-parish relationships. Fr. Canizares spoke about the regional schools which require pastors to pledge support.

Msgr. Rossi made the motion to recommend acceptance of the proposed budget by the Cardinal. Msgr. Sheltz seconded the motion. The Council affirmed the motion by voice vote. The Council thanked Mr. Hessel and Ms. Heinrichs for their work on the budget.

IMPLEMENTATION OF THE NEW TRANSLATION OF THE ROMAN MISSAL: Mr. David Wood, Director of the Archdiocesan Office of Worship, and Fr. James Burkart, Chair of the Archdiocesan Liturgical Commission, presented the Proposed Implementation Plan for the New Translation of the Roman Missal, 3rd ed. This translation applies to the 12 English speaking episcopal conferences throughout the world. Cardinal DiNardo is speculating the date of implementation may be Advent 2011. However, the USCCB have yet to meet and decide the date. It will take at least a year for the publishers to produce the books. While the changes in the Missal have the *recognitio* of the Holy See, Rome is still working on editing the text. Dioceses are beginning preparations for implementation.

Fr. Burkart said the proposed plan would provide for three levels of preparation:

Level I — Archdiocesan Level: Formation of Priests and Key Archdiocesan Leadership

Level II — Deanery level: Formation of Key Parish Leadership (Implementation Teams)

Level III — Parish Level:

- A. Development of a Parish Implementation Team and Parish Plan
- B. Formation for Faithful in the Pews

Fr. Burkart discussed some of the published materials that are being made available. One example was *Become One Body One Spirit in Christ* which presents an opportunity to

provide formation on the spirituality of the Mass as well as a packaged the catechetical preparation program for implementing the new translation of the Missal. The Federation of Diocesan Liturgical Commissions (FDLC) has some Power Point presentations, one for the clergy and one for the laity. Cardinal DiNardo noted the greatest change is going to impact the clergy, especially priests. All the orations are changed as well as the Eucharistic prayers. The emphasis will be on helping priests to prepare. Mr. Wood said one advantage for priests who minister in English and Spanish is that they will find greater alignment between the Spanish and the English missals. Deacons will not be heavily impacted. Changes impacting the laity are the Gloria, the Creed, the Sanctus, etc. These will not be so difficult to implement as the changes are not so dramatic.

Fr. Burkart said there is the possibility of utilizing the Msgr. William D. Steele Lecture for bringing Msgr. James Maroney or another national speaker in as one opportunity for helping priests to prepare for the implementation.

Another possibility is to form teams to go to a series of five or six deanery meetings to meet with priests so as to foster dialogue and to answer questions priests may have. Parish implementation teams would inform people about the changes in the translation and prepare them to receive them well. It is hoped that this would help bring about renewal for priests enabling them to in turn bring to their parishes an awareness concerning the spirituality of the Mass.

Mr. Wood mentioned that Liiturgical Training Publications (LTP) has a good resource of materials prepared by Fr. Paul Turner. These may be used to do smaller group preparation on the parish level.

Fr. Canizares asked about the missalettes publishers getting up to speed. Fr. Burkart expressed the hope that the laity would not become so dependent on the missalettes. The hope is that there an insert card would be produced that could easily handle the changes for the laity in the pews.

Cardinal added that the Worship Office is working on the presupposition that, given past experiences, simply giving the texts in printed form is insufficient. There is a great need to offer formation to both priests and laity on the theological, liturgical and spiritual meaning of the texts. The priests have to be well enough formed so as to be able to pass that on to the laity. The Archdiocese will provide training and materials but the real work will be on the parish level. Cardinal's concern is for the priests because there is so much more change that applies to priests.

Fr. Cahill raised a question about the timeline for unfolding the presentations. Cardinal indicated we should begin the preparations no matter when the date of implementation of the new translation is so we can be ready when that time comes. He said some of the pastoral ministers and music ministers are well on their way in preparing and planning.

Fr. Burkart said the *FDLC.org* website is doing preparations and the Southwest Liturgical Conference next year in Utah is dedicated to the new translation. Mr. Wood has spoken to bulletin publishers about possible bulletin inserts for use in parishes.

Cardinal indicated that we will need to use various means of informing the people in the pews as well as those who attend less frequently. There was some discussion around ways of getting the word out which could include utilizing the internet, newspaper, multimedia, television, etc.

Msgr. Rossi asked that attention be given to the needs of foreign born priest in helping them to make the necessary adjustments. Cardinal indicated that the Schools, CCE, and Youth Ministry Offices would be involved in this effort.

Priests are encouraged to being remote preparation now by various websites, especially the USCCB site, for the texts of the Eucharistic prayers and related articles, and other good resources. The Office of Worship will continue to provide updates throughout the coming year.

2010 CONVOCATION MINISTRY TO PRIEST DAYS: The evaluation results were reviewed. In general, the convocation was well received. Attendance was 192 priests this year, down about 20-25 from past years. Moody Gardens continues to be a favorable location given Galveston's history with the local church and the hotel's willingness to work with us to offer the most favorable rates. The survey feedback indicated priests would have preferred more table conversation, and a good list of future topics for convocations was generated.

There was some discussion around what could be done to encourage more priests to attend. It was recognized that some priests are prevented from being present for all or part of the convocation due to ministerial duties, for example priests in the hospital chaplaincy and priests in teaching ministries. The timing of the conference was questioned. It seems that that timeframe seems to be the best for most priests and that it seems nearly impossible to find a timeframe at which all priests could be present. The hotel conference rates are also much less expensive prior to Memorial Day than after. It was noted that some priests simply refuse to come to any diocesan events, even to the point of not attending deanery meetings, days of prayer and reflection or the Chrism Mass. It was suggested that priests try to make contact with priests who have not been present in the past and encourage them fraternally to attend.

Msgr. Sheltz and Cardinal DiNardo expressed additional concern that priests make their annual canonical retreat. The Cardinal thanked the Committee for Ongoing Formation for Priests for their good work on the convocation.

<u>CARDINAL'S CONSULTATION AND ANNOUNCEMENTS</u>: Cardinal DiNardo stated that there are some priests retiring this year and that this can be a difficult transition for them. He encouraged support for those who are retiring and visits to the retired priests.

Cardinal told the group that there are a good number of men applying for admission to the seminary. We have accepted eight men so far. Fr. Cahill said that younger men, high school graduates and college aged, are applying to the seminary at present.

Cardinal noted the upcoming priesthood of Deacon Joe Doran on July 10 and encouraged priests to attend.

Cardinal said that Msgrs. Sheltz and Rossi have been delegated to minister the Sacrament of Confirmation, and he thanked Archbishop Fiorenza and Bishop Rizzotto for their willingness to help in retirement as well.

On the topic of immigration reform, Cardinal said he is asking pastors to preach on it for the July 4 weekend. Almost all the Protestant leaders will be taking up the topic together. Cardinal will be sending out a letter with accompanying materials asking priests to preach as a voice of reason in a debate that has become more "angular and angry" from both sides. We can support both, securing our borders and care for the immigrants and their families.

As has become a custom in the Archdiocese, the entire collection for Corpus Christi Sunday is to be sent to the Chancery for the support of St. Mary's Seminary.

Fr. Cloutier raised the question concerning an official priest's identification card (*celebret*). Fr. Horrigan said that there is one available for priests by going to University of St. Thomas Registrar's office to have their picture taken and a card made.
